   Finland, the Netherlands, and Italy.













# Transitional Regime (Art. 83 of the UPCA)

"ARTICLE 83

#### Transitional regime

- (1) During a transitional period of seven years after the date of entry into force of this Agreement, <u>an action for infringement or for revocation of a European patent</u> or an action for infringement or for declaration of invalidity of a supplementary protection certificate issued for a product protected by a European patent <u>may still be brought before national courts</u> or other competent national authorities.
- (2) An action pending before a national court at the end of the transitional period shall not be affected by the expiry of this period.
- (3) <u>Unless an action has already been brought before the Court</u>, a proprietor of or an applicant for a European patent granted or applied for prior to the end of the transitional period under paragraph 1 and, where applicable, paragraph 5, as well as a holder of a supplementary protection certificate issued for a product protected by a European patent, shall have <u>the possibility</u> to opt out from the exclusive competence of the Court. To this end they shall notify their opt-out to the Registry by the latest one month before expiry of the transitional period. The opt-out shall take effect upon its entry into the register.
- (4) <u>Unless an action has already been brought before a national court</u>, proprietors of or applicants for European patents or holders of supplementary protection certificates issued for a product protected by a European patent who made use of the opt-out in accordance with paragraph 3 shall be <u>entitled to withdraw their opt-out at any moment</u>. In this event they shall notify the Registry accordingly. The withdrawal of the opt-out shall take effect upon its entry into the register.


